

# Look For Relevant Emissions Durability Period and Air Index Information On Your Engine Emissions Label

Engines that are certified to meet the California Air Resources Board (CARB) Tier 2 Emission Standards must display information regarding the Emissions Durability Period and the Air Index. Briggs & Stratton makes this information available to the consumer on our emission labels. The engine emission label will indicate certification information.

The **Emissions Durability Period** describes the number of hours of actual running time for which the engine is certified to be emissions compliant, assuming proper maintenance in accordance with the Operating & Maintenance Instructions. The following categories are used:

Moderate: Engine is certified to be emission compliant for 125 hours of actual engine running time.

Intermediate: Engine is certified to be emission compliant for 250 hours of actual engine running time.

Extended: Engine is certified to be emission compliant for 500 hours of actual engine running time.

For example, a typical walk-behind lawn mower is used 20 to 25 hours per year. Therefore, the **Emissions Durability Period** of an engine with an **intermediate** rating would equate to 10 to 12 years.

The **Air Index** is a calculated number describing the relative level of emissions for a specific engine family. The lower the **Air Index**, the cleaner the engine. This information is displayed in graphical form on the emissions label.

# After July 1, 2000, Look For Emissions Compliance Period On Engine Emissions Compliance Label


After July 1, 2000 certain Briggs & Stratton engines will be certified to meet the United States Environmental Protection Agency (USEPA) Phase 2 emission standards. For Phase 2 certified engines, the Emissions Compliance Period referred to on the Emissions Compliance label indicates the number of operating hours for which the engine has been shown to meet Federal emission requirements. For engines less than 225 cc displacement, Category C = 125 hours, B = 250 hours and A = 500 hours. For engines of 225 cc or more, Category C = 250 hours, B = 500 hours and A = 1000 hours.

The displacement of INTEK™ Model Series 110000 engine is 167 cc, INTEK™ Model Series 120000 engine is 190 cc.

The displacement of QUANTUM® Model Series 120000 engine is 190 cc.

This is a generic representation of the emission label typically found on a certified engine.

- · Make you aware of hazards associated with engines

The safety alert symbol ( ) is used to identify safety information about hazards that can result in personal injury.

A signal word (DANGER, WARNING, or CAUTION) is used with the alert symbol to indicate the likelihood and the potential severity of injury. In addition, a hazard symbol may be used to represent the type of hazard.



**DANGER** indicates a hazard which, if not avoided, will result in death or serious injury.





Gasoline and its vapors are extremely flammable and explosive.

Fire or explosion can cause severe burns or death.

### WHEN ADDING FUEL

- Turn engine OFF and let engine cool at least 2 minutes before removing gas cap.
- Fill fuel tank outdoors or in well-ventilated area.
- Do not overfill fuel tank. Fill tank to approximately 1-1/2 inches below top of neck to allow for fuel expansion.
- Keep gasoline away from sparks, open flames, pilot lights, heat, and other ignition sources.
- Check fuel lines, tank, cap, and fittings frequently for cracks or leaks. Replace if necessary.

### WHEN STARTING ENGINE

- Make sure spark plug, muffler, fuel cap and air cleaner are in place.
- Do not crank engine with spark plug removed.
- If fuel spills, wait until it evaporates before starting engine.
- If engine floods, set choke to OPEN/RUN position, place throttle in FAST and crank until engine starts.

### WHEN OPERATING EQUIPMENT

- Do not tip engine or equipment at angle which causes gasoline to spill.
- Do not choke carburetor to stop engine.

### WHEN TRANSPORTING EQUIPMENT

Transport with fuel tank EMPTY or with fuel shut-off valve

# WHEN STORING GASOLINE OR EQUIPMENT WITH FUEL IN TANK

 Store away from furnaces, stoves, water heaters or other appliances that have pilot light or other ignition source because they can ignite gasoline vapors.





Starting engine creates sparking.

Sparking can ignite nearby flammable gases.

Explosion and fire could result.

- If there is natural or LP gas leakage in area, do not start engine.
- Do not use pressurized starting fluids because vapors are flammable.

# **MARNING**



Unintentional sparking can result in fire or electric shock. Unintentional start-up can result in entanglement, traumatic amputation, or laceration.

### **BEFORE PERFORMING ADJUSTMENTS OR REPAIRS**

- Disconnect spark plug wire and keep it away from spark plug.
- Disconnect battery at negative terminal (only engines with electric start).

#### WHEN TESTING FOR SPARK

- Use approved spark plug tester.
- Do not check for spark with spark plug removed.





Engines give off carbon monoxide, an odorless, colorless, poison gas.

Breathing carbon monoxide can cause nausea, fainting or death.

- · Start and run engine outdoors.
- Do not start or run engine in enclosed area, even if doors or windows are open.



# **WARNING**



Rotating parts can contact or entangle hands, feet, hair, clothing, or accessories.

Traumatic amputation or severe laceration can result.

- Operate equipment with guards in place.
- Keep hands and feet away from rotating parts.
- · Tie up long hair and remove jewelry.
- Do not wear loose-fitting clothing, dangling drawstrings or items that could become caught.



# WARNING



Running engines produce heat. Engine parts, especially muffler, become extremely hot.

Severe thermal burns can occur on contact.

Combustible debris, such as leaves, grass, brush, etc. can catch fire.

- Allow muffler, engine cylinder and fins to cool before touching.
- Remove accumulated combustibles from muffler area. and cylinder area.
- Install and maintain in working order a spark arrester before using equipment on forest-covered, grass-covered, brush-covered unimproved land. The state of California requires this (Section 4442 of the California Public Resources Code). Other states may have similar laws. Federal laws apply on federal land.



# WARNING



Rapid retraction of starter cord (kickback) will pull hand and arm toward engine faster than you can let go.

Broken bones, fractures, bruises or sprains could result.

- When starting engine, pull cord slowly until resistance is felt, then pull rapidly.
- Remove all external equipment/engine loads before starting engine.
- Direct coupled equipment components such as, but not limited to, blades, impellors, pulleys, sprockets, etc., must be securely attached.

# **WARNING**



Touch-N-Mow™ Starting System: If these instructions are not followed, traumatic amputation or severe laceration can result.

- ALWAYS disconnect spark plug, de-energize starter, lock and remove safety key BEFORE performing ANY service to the engine or mower. (See section To De-Energize Touch-N-Mow ™ Starter on page 13.)
- DO NOT attempt any maintenance or repairs to the Touch-N-Mow™ starter.
- NEVER assume starter is de-energized, even if key is in LOCK AND REMOVE position and/or removed from engine.
- BEFORE removing grass or other debris from under mower deck; BEFÖRE changing oil, air filter or spark BEFORE removing blade for servicing; BEFORE performing any other service to engine or mower; BEFORE transporting mower - ALWAYS DE-ENERGIZE TOUCH-N-MOW STARTER.
- ALWAYS lock and remove safety key and store in safe place until next use. The safety key is designed and intended to be removed from engine when not in use. Removing key will prevent unsupervised or unexpected starting of mower by children or unsuspecting adults. The safety key must be in locked position before it can be removed.





## INTEK™ GENERAL INFORMATION **ENGINE MODEL**

This is a single cylinder, overhead valve (OHV). It is a low emissions engine.

In the state of California, OHV Model Series 110000 and 120000 engines are certified by the California Air Resources Board to meet emissions standards for 125 hours. Such certification does not grant the purchaser, owner or operator of this engine any additional warranties with respect to the performance or operational life of this engine. This engine is warranted solely according to the product and emissions warranties stated elsewhere in this manual.

# INTEK™ MODEL SERIES 110000

### INTEK™ MODEL SERIES 120000

Bore ..... 2-11/16 in. (68.26 mm) Stroke ...... 2-3/64 in. (52.00 mm) 

Note: For practical operation, the horsepower loading should not exceed 85% of rated horsepower. Engine power will decrease 3-1/2% for each 1,000 feet (300 meters) above sea level and 1% for each 10° F (5.6° C) above 77° F (25° C). It will operate satisfactorily at an angle up to 15°.



### **CAUTION:**

This engine is shipped from Briggs & Stratton without oil. Check oil level before starting engine. If you start the engine without oil, the engine will be damaged beyond repair and will not be covered under warranty.

### OIL CAPACITY


Engine holds approximately 5/8 quart (20 ounces; 0.6 liter).

### TYPE OF OIL TO USE

- Use a high quality detergent oil classified "For Service SF, SG, SH, SJ" or higher, such as Briggs & Stratton 30W, Part Number 100005 (20 oz) or 100028 (48 oz).
- · Do not use special additives.
- Choose a viscosity according to the table opposite.




**Note:** Synthetic oil meeting ILSAC GF-2, API certification mark and API service symbol (shown at left) with "SJ/CF ENERGY CONSERVING" or higher, is an acceptable oil at all temperatures. **Use of synthetic oil does not alter required oil change intervals**.



- \* CAUTION: Air cooled engines run hotter than automotive engines. The use of non-synthetic multi-viscosity oils (5W-30, 10W-30, etc.) in temperatures above 40° F (4° C) will result in higher than normal oil consumption. When using a multi-viscosity oil, check oil level more frequently.
- \*\* **CAUTION:** SAE 30 oil, if used below 40° F (4° C), will result in hard starting and possible engine bore damage due to inadequate lubrication.

### ADDING OIL

[1] Place engine level and clean around oil fill area.



- [2] Remove dipstick and wipe clean with cloth.
- [3] Replace and tighten dipstick. Remove and check oil level.
- [4] Oil level should be at FULL line on dipstick.
- [5] If needed, add oil slowly recheck.

Do not over fill.

[6] Replace and tighten dipstick.



### **CAUTION:**

Do not overfill. Overfilling with oil may cause:

Smoking, Hard starting, Spark plug fouling, or Oil saturation of air filter.

- Check oil level before starting the engine.
- Check level daily, or after every eight (8) hours.
- Keep oil level at FULL.

See also **Maintenance** section for instructions on changing oil and scheduled maintenance intervals.

### **CAUTION:**

If engine is tipped to transport equipment, remove grass, drain oil, etc., **keep spark plug side of engine up**. Tipping engine with spark plug down may cause:

KEEP SPARK PLUG UP

- · Smoking.
- · Hard starting,
- Spark plug fouling,
- Oil saturation of air filter.

### TYPE OF FUEL TO USE

Use clean, fresh, regular unleaded gasoline with a minimum of 77 octane.

### INTEK™

### TYPE OF FUEL TO USE

Use clean, fresh, regular unleaded gasoline with a minimum of 85 octane.

**CAUTION:** Some fuels, called oxygenated or reformulated gasoline, are gasoline blended with alcohols or ethers. Excessive amounts of these blends can damage the fuel system or cause performance problems. If any undesirable operating symptoms occur, use gasoline with a lower percentage of alcohol or ether.

- Fresh fuel prevents gum from forming in the fuel system or on essential carburetor parts. Purchase fuel in quantity that can be used within 30 days.
- Do not use gasoline which contains Methanol.
- Do not mix oil with gasoline.
- For engine protection use Briggs & Stratton Gasoline Additive available from your Authorized Briggs & Stratton Dealer (P/N 5041 or single use pouch).
- This engine is certified to operate on gasoline. Exhaust Emission Control System: EM (Engine Modifications).



### **WARNING**



- · Do not use pressurized starting fluids.
- · Vapors are flammable.

### **ADDING FUEL**

**CAUTION:** Engine is often shipped with a blue plug in the fuel fill, remove and <u>discard</u>. It is not a component of the fuel tank.



### **WARNING**






Fill fuel tank outdoors or in well-ventilated area, away from sparks, open flames, pilot lights, heat, and other ignition sources.

If fuel spills, wait until it evaporates before starting engine.

Turn engine OFF and let engine cool at least 2 minutes before removing gas cap.



- [1] Remove cap. Fill tank to approximately 1-1/2 inches below top of neck to allow for fuel expansion. Be careful not to overfill.
  - Briggs & Stratton *Smart-fill*® fuel can fills to the correct level and automatically shuts off, reducing spills and emissions.
- [2] Replace cap before starting.

Touch-N-Mow™ Starting System: If these instructions are not followed, traumatic amputation or severe laceration can result.

# **WARNING**



- ALWAYS disconnect spark plug, de-energize starter, lock and remove safety key BEFORE performing ANY service to the engine or mower. (See section *To De-Energize Touch-N-Mow™ Starter* on page 13.)

### To Start Engine First Time

### OR when the Touch-N-Mow™ starter is De-Energized

(See section To De-Energize Touch-N-Mow™ Starter, Page 13)

The Touch-N-Mow™ starting system is shipped in a de-energized state. To energize this starting system, you must first start the engine using the rewind (manual) starter. The Touch-N-Mow™ starter will not be energized until a complete startup and shutdown procedure have been completed.

### **BEFORE STARTING**

- Place lawn mower on level surface outdoors.
- Add fuel.
- ◆ Add and check oil. Ensure oil level is FULL.
- Push spark plug wire firmly on to spark plug.
- ◆ Open fuel shut off valve. (IF EQUIPPED)
- [1] Install safety key in locked position. Be sure to read and retain helpful starting tips enclosed with packaging of the safety key.
- [2] Turn safety key to RUN position (1/4 turn toward fuel
- Press engine primer bulb 3 times.



WARNING: A typical equipment control configuration is shown. (See equipment manufacturer's owner/operating manual for specific instructions on equipment control configuration and operation.)


[4] Actuate equipment starting controls according to instructions in manufacturer's owner/operating manual.




**WARNING:** [5] Grasp rope handle. Pull slowly until resistance is felt, then pull rapidly to start engine and avoid kickback.

**Note:** If engine does not start on second pull, press engine primer bulb 3 times again and repeat steps 4 and 5.

The Touch-N-Mow™ starting system is not energized yet. To energize the Touch-N-Mow™ starting system, see section To Stop Engine | Energize Touch-N-Mow \*\* System, page 13.





## STARTING AND STOPPING



### To Stop Engine / Energize Touch-N-Mow™ Starting System

Touch-N-Mow™ starting system is functioning properly when a mechanical winding/ratcheting sound is heard upon releasing equipment control handle. This is the sound of the Touch-N-Mow™ starting system energizing for the next start. Engine must be running to energize Touch-N-Mow™ Starting System.


- [1] Release equipment control handle per equipment manufacturer's instructions.
- [2] ALWAYS lock safety key as shown and remove when not in use. Turn safety key to LOCK AND REMOVE position (1/4 turn opposite fuel cap) and remove.
- [3] Close fuel shut-off valve (if equipped).



**WARNING:** A typical equipment control configuration is shown. (See equipment manufacturer's owner/operating manual for specific instructions on equipment control configuration and operation.)







### **OPERATING TIPS**

- Use fresh fuel. Use correct type of oil for expected starting temperature.
- Remove external equipment/engine loads before starting. (See equipment operating instructions.)
- Start lawn mower on hard surface or over previously cut grass.
- Periodically remove grass buildup under mower deck.
- After engine has started, let it warm up several seconds to several minutes, depending on outside temperature.
- For maximum performance and life, operate engine with choke (if equipped) in RUN and throttle in FAST.

### To Start Warm Engine

- [1] A warm engine DOES NOT require priming.
- [2] Install and turn safety key to RUN position (1/4 turn toward fuel cap).
- [3] Actuate equipment starting controls according to instructions in manufacturer's owner/operating manual.

**Note:** If for some reason engine does not start on first attempt using Touch-N-Mow™ starter, you must use rewind starter to re-start engine. Press engine primer bulb 3 times and start according to manufacturer's owner/operating manual.

### To Start Cold or Stored Engine

- [1] Check oil level (See Oil section).
- [2] Press engine primer bulb 3 times.
- [3] Install and turn safety key to RUN position (1/4 turn toward fuel cap).
- [4] Actuate equipment starting controls according to instructions in manufacturer's owner/operating manual.

**Note:** If for some reason engine does not start on first attempt using Touch-N-Mow™ starter, you must use rewind starter to re-start engine. Press engine primer bulb 3 times and start according to manufacturer's owner/operating manual.

### To <u>De-energize</u> Touch-N-Mow<sup>™</sup> Starter


Before servicing, storing, or transporting engine, ensure the starter is not energized by manually de-energizing it.

Warning: Keep hands and feet away from rotating parts. The engine will turn over when de-energizing.

- [1] Remove spark plug wire from spark plug.
- [2] Turn safety key to RUN position (1/4 turn toward fuel cap).
- [3] Actuate equipment starting controls according to instructions in manufacturer's owner/operating manual.

Engine will crank over upon actuating equipment starting controls, but will not start if spark plug wire was removed from spark plug as described above. Once engine has stopped cranking, Touch-N-Mow™ starter is de-energized.

[4] Turn safety key to LOCK AND REMOVE position (1/4 turn opposite fuel cap) and remove key. Mower or engine may now be safely serviced or stored.

### **MAINTENANCE**

Regular maintenance will improve the performance and extend the life of the engine. See any Authorized Briggs & Stratton Dealer for service. <u>Use only genuine Briggs & Stratton parts. Other parts may not perform as well, may damage the engine, and may result in injury.</u> In addition, use of other parts may void your warranty.

- \* Change oil after first 5 to 8 hours of use, then every 50 hours or every season. Change oil every 25 hours when operating the engine under heavy load or in high temperatures.
- \*\* Clean more often under dusty conditions or when airborne debris is present. Replace air cleaner parts, if very dirty.

**CAUTION:** Used oil is a hazardous waste product. Dispose of used oil properly. Do not discard with household waste. Check with your local authorities, service center, or dealer for safe disposal/recycling facilities.

### **EMISSION CONTROL**

Maintenance, replacement or repair of the emission control devices and systems may be performed by any nonroad engine repair establishment or individual. However, to obtain no charge repairs under the terms and provisions of the Briggs & Stratton warranty statement, any service or emission control part repair or replacement must be performed by a factory authorized dealer.






# CHANGING OIL







WARNING


] Run engine until it runs out of fuel. Otherwise, fuel can leak out, creating a fire/explosion hazard, when you tip engine in Step 4.

- [2] Disconnect spark plug wire and keep it away from spark plug. De-energize starter, and lock and remove safety key. (See Page 13)
- [3] With engine OFF but still warm remove dipstick.
- [4] Top oil drain, keep air cleaner above oil outlet. Bottom or side oil drain (if equipped), keep engine level. Drain oil into appropriate receptacle.

**Note:** Top oil drain is recommended method, however oil can drain from side (if equipped) or bottom as shown.

[5] Place engine level. Add about 5/8 quart (20 ounces: 0.6 liter) new oil. Fill to FULL line on dipstick. **Do not overfill.** Replace dipstick.




# CHANGING OIL FILTER (if equipped)

- [1] After draining engine of used oil, fill with fresh oil.
- [2] Before installing new filter, lightly oil filter gasket with fresh, clean oil.
- [3] Screw filter on by hand until gasket contacts oil filter adapter.
- [4] Tighten 1/2 to 3/4 turn more.
- [5] Start and run engine at idle to check for leaks.
- [6] Stop engine. Re-check oil level. Add oil if required.



### AIR CLEANER


All engines have an air cleaner cartridge. The cartridge is either flat or oval (see illustrations). In addition, some engines have a pre-cleaner.



# REMOVING AND RE-INSTALLING FLAT AIR CLEANER

- [1] Loosen screw and tilt cover down.
- [2] Remove air cleaner.
- [3] Re-install clean (or new) air cleaner assembly inside cover. Lip of pre-cleaner (if equipped) must be at bottom of cartridge pleats.
- [4] Insert cover's tabs into slots in bottom of base.
- [5] Tilt cover up into place and tighten screw.

**CAUTION:** Do not use pressurized air or solvents to clean cartridge. Pressurized air can damage cartridge; solvents will dissolve cartridge.



# REMOVING AND RE-INSTALLING OVAL AIR CLEANER

- [1] Loosen two screws and lift off cover.
- [2] Remove air cleaner assembly (pre-cleaner, if equipped, and cartridge) from base.
- [3] Re-install clean (or new) air cleaner assembly in base. Air cleaner must fit securely in base.
- [4] Place cover over air cleaner and tighten screws.

### **ENGINE AND ENGINE PARTS**

We recommend that you see an authorized Briggs & Stratton Service Dealer for all maintenance and service of the engine and engine parts. Use only genuine Briggs & Stratton parts.


- Do not strike the flywheel with a hammer or hard object because the flywheel may later shatter during operation.
- Do not tamper with governor spring, links or other parts to increase engine speed.

### **FUEL SYSTEM**



Replacement parts for fuel system (cap, hoses, tanks, filters, etc.) must be the same as original parts, otherwise fire can occur.

### REPLACE FUEL FILTER (IF EQUIPPED)





- [1] Disconnect spark plug wire and keep away from spark plug. De-energize starter. Lock and remove safety key. (See Page 13)
- [2] Drain fuel tank or close fuel shut-off valve before replacing fuel filter. Otherwise, fuel can leak out, creating a fire/explosion hazard.

### **MUFFLER**



Replacement parts for the muffler must be the same and installed in the same position as the original parts, otherwise fire can occur.


If muffler is equipped with spark arrester screen, re-

move screen for inspection. Replace screen if damaged or plugged.

### SPARK PLUG

Use only Briggs & Stratton Spark Tester (part number 19368) to check for spark.

**Note:** In some areas, local law requires using resistor spark plug to suppress ignition signals. If this engine was originally equipped with resistor spark plug, use same type for replacement.



### **COMBUSTION DEPOSITS**

We recommend that after every 100-300 hours you have an authorized Briggs & Stratton Service Dealer remove combustion deposits from the cylinder, cylinder head, top of piston, and around valves.

### AIR COOLING SYSTEM

We recommend that after every 100 hours you have an authorized Briggs & Stratton Service Dealer clean the air cooling system.

Over time debris may accumulate in cylinder cooling fins and cannot be observed without partial engine disassembly. For this reason, we recommend that you have an authorized Briggs & Stratton Service Dealer clean the air cooling system per recommended intervals. Equally important is to keep top of engine free from debris.

### **VALVE CLEARANCE**



### **CLEANING DEBRIS**


**CAUTION:** Do not use water to clean engine parts. Water could contaminate fuel system. Use a brush or dry cloth.

Daily or before every use, clean grass, chaff or accumulated debris from engine. Keep debris guard clean. Keep linkage, spring and controls clean. Keep area around and behind muffler free of any combustible debris.





Engine parts should be kept clean to reduce the risk of overheating and ignition of accumulated debris. This is especially important if cutting tall grass.





# **ADJUSTMENTS**







Prevent unintentional starting. Before performing adjustments:

- · Remove spark plug wire from spark plug.
- Disconnect battery at negative terminal (only engines with electric start).
- ALWAYS de-energize starter, lock and remove safety key. (See section To De-Energize Touch-N-Mow™ Starter on page 13.)





The California Air Resources Board (CARB), U.S. EPA and B&S are pleased to explain the Emission Control System Warranty on your model year 2000 and later small off-road engine (SORE). In California, new small off-road engines must be designed, built and equipped to meet the State's stringent anti-smog standards. Elsewhere in the United States, new non-road, spark-ignition engines certified for model year 1997 and later must meet similar standards set forth by the U.S. EPA. B&S must warrant the emission control system on your engine for

the periods of time listed below, provided there has been no abuse, neglect or improper maintenance of your small off-road engine. Your emission control system includes parts such as the carburetor, air cleaner, ignition system, muffler and catalytic converter. Also in-

air cleaner, ignition system, muffler and catalytic converter. Also included may be connectors and other emission related assemblies. Where a warrantable condition exists, B&S will repair your small offroad engine at no cost to you including diagnosis, parts and labor.

### **Briggs & Stratton Emission Control Defects Warranty Coverage**

Small off-road engines are warranted relative to emission control parts defects for a period of two years, subject to provisions set forth

below. If any covered part on your engine is defective, the part will be repaired or replaced by B&S.

### **Owner's Warranty Responsibilities**

As the small off-road engine owner, you are responsible for the performance of the required maintenance listed in your Operating and Maintenance Instructions. B&S recommends that you retain all your receipts covering maintenance on your small off-road engine, but B&S cannot deny warranty solely for the lack of receipts or for your failure to ensure the performance of all scheduled maintenance.

As the small off-road engine owner, you should however be aware that B&S may deny you warranty coverage if your small off-road engine or a part has failed due to abuse, neglect, improper maintenance or unapproved modifications.

You are responsible for presenting your small off-road engine to an Authorized B&S Service Dealer as soon as a problem exists. The undisputed warranty repairs should be completed in a reasonable amount of time, not to exceed 30 days.

If you have any questions regarding your warranty rights and responsibilities, you should contact a B&S Service Representative at 1-414-259-5262.

The emission warranty is a defects warranty. Defects are judged on normal engine performance. The warranty is not related to an in-use emission test.

### **Briggs & Stratton Emission Control Defects Warranty Provisions**

The following are specific provisions relative to your Emission Control Defects Warranty Coverage. It is in addition to the B&S engine warranty for non-regulated engines found in the Operating and Maintenance Instructions.

1. Warranted Parts

Coverage under this warranty extends only to the parts listed below (the emission control systems parts) to the extent these parts were present on the engine purchased.

- a. Fuel Metering System
  - Cold start enrichment system
  - · Carburetor and internal parts
  - Fuel Pump
- b. Air Induction System
  - Air cleaner
  - Intake manifold
- Ignition System
  - Spark plug(s)
  - Magneto ignition system
- d. Catalyst System
  - Catalytic converter
  - Exhaust manifold
  - Air injection system or pulse valve
- e. Miscellaneous Items Used in Above Systems
  - Vacuum, temperature, position, time sensitive valves and switches
  - · Connectors and assemblies

### 2. Length of Coverage

B&S warrants to the initial owner and each subsequent purchaser that the Warranted Parts shall be free from defects in materials and workmanship which caused the failure of the Warranted Parts for a period of two years from the date the engine is delivered to a retail purchaser.

### 3. No Charge

Repair or replacement of any Warranted Part will be performed at no charge to the owner, including diagnostic labor which leads to the determination that a Warranted Part is defective, if the diagnostic work is performed at an Authorized B&S Service Dealer. For emissions warranty service contact your nearest Authorized B&S Service Dealer as listed in the "Yellow Pages" under "Engines, Gasoline," "Gasoline Engines," "Lawn Mowers," or similar category.

4. Claims and Coverage Exclusions

Warranty claims shall be filed in accordance with the provisions of the B&S Engine Warranty Policy. Warranty coverage shall be excluded for failures of Warranted Parts which are not original B&S parts or because of abuse, neglect or improper maintenance as set forth in the B&S Engine Warranty Policy. B&S is not liable to cover failures of Warranted Parts caused by the use of add-on, non-original, or modified parts.

5. Maintenance

Any Warranted Part which is not scheduled for replacement as required maintenance or which is scheduled only for regular inspection to the effect of "repair or replace as necessary" shall be warranted as to defects for the warranty period. Any Warranted Part which is scheduled for replacement as required maintenance shall be warranted as to defects only for the period of time up to the first scheduled replacement for that part. Any replacement part that is equivalent in performance and durability may be used in the performance of any maintenance or repairs. The owner is responsible for the performance of all required maintenance, as defined in the B&S Operating and Maintenance Instructions.

6. Consequential Coverage

Coverage hereunder shall extend to the failure of any engine components caused by the failure of any Warranted Part still under warranty.

In the USA and Canada, a 24 hour hot line, 1-800-233-3723, has a menu of pre-recorded messages offering you engine maintenance information.

About your engine warranty: (see next page for statement of LIMITED WARRANTY).

Briggs & Stratton welcomes warranty repair and apologizes to you for being inconvenienced. Any Authorized Service Dealer may perform warranty repairs. Most warranty repairs are handled routinely, but sometimes requests for warranty service may not be appropriate. For example, warranty would not apply if engine damage occurred because of misuse, lack of routine maintenance, shipping, handling, warehousing or improper installation. Similarly, warranty is void if the serial number of the engine has been removed or the engine has been altered or modified.

If a customer differs with the decision of the Service Dealer, an investigation will be made to determine whether the warranty applies. Ask the Service Dealer to submit all supporting facts to its Distributor or the Factory for review. If the Distributor or the Factory decides that the claim is justified, the customer will be fully reimbursed for those items that are defective. To avoid misunderstanding which might occur between the customer and the Dealer, listed below are some of the causes of engine failure that the warranty does not cover.

### Normal wear:

Engines, like all mechanical devices, need periodic parts service and replacement to perform well. Warranty will not cover repair when normal use has exhausted the life of a part or an engine.

### Improper maintenance:

The life of an engine depends upon the conditions under which it operates, and the care it receives. Some applications, such as tillers, pumps and rotary mowers, are very often used in dusty or dirty conditions, which can cause what appears to be premature wear. Such wear, when caused by dirt, dust, spark plug cleaning grit, or other abrasive material that has entered the engine because of improper maintenance, is not covered by warranty.

This warranty covers engine related defective material and/or workmanship <u>only</u>, and not replacement or refund of the equipment to which the engine may be mounted. Nor does the warranty extend to repairs required because of:

- PROBLEMS CAUSED BY PARTS THAT ARE NOT ORIGINAL BRIGGS & STRATTON PARTS.
- 2. Equipment controls or installations that prevent starting, cause unsatisfactory engine performance, or shorten engine life. (Contact equipment manufacturer.)
- Leaking carburetors, clogged fuel pipes, sticking valves, or other damage, caused by using contaminated or stale fuel. (Use clean, fresh, lead-free gasoline and Briggs & Stratton gasoline stabilizer, Part No. 5041.)

- 4. Parts which are scored or broken because an engine was operated with insufficient or contaminated lubricating oil, or an incorrect grade of lubricating oil. Refill when necessary; OIL GARD® may not shut down running engine. Engine damage may occur if oil level is not properly maintained. Read the recommended maintenance intervals for your engine outlined in the Operating & Maintenance Instructions.
- Repair or adjustment of associated parts or assemblies such as clutches, transmissions, remote controls, etc., which are not manufactured by Briggs & Stratton.
- 6. Damage or wear to parts caused by dirt, which entered the engine because of improper air cleaner maintenance, re-assembly, or use of a non-original air cleaner element or cartridge. Read the recommended maintenance intervals for your engine outlined in the Operating & Maintenance Instructions.
- 7. Parts damaged by overspeeding, or overheating caused by grass, debris, or dirt, which plugs or clogs the cooling fins, or flywheel area, or damage caused by operating the engine in a confined area without sufficient ventilation. Read the recommended maintenance intervals for your engine outlined in the Operating & Maintenance Instructions.
- Engine or equipment parts broken by excessive vibration caused by a loose engine mounting, loose cutter blades, unbalanced blades or loose or unbalanced impellers, improper attachment of equipment to engine crankshaft, overspeeding or other abuse in operation.
- A bent or broken crankshaft, caused by striking a solid object with the cutter blade of a rotary lawn mower, or excessive v-belt tightness.
- 10. Routine tune-up or adjustment of the engine.
- 11. Engine or engine component failure, i.e., combustion chamber, valves, valve seats, valve guides, or burned starter motor windings, caused by the use of alternate fuels such as liquified petroleum, natural gas, altered gasolines, etc.
