LIMITED WARRANTY FOR TROY-BILT BATTERY-POWERED LITHIUM-ION RIDERS

LIMITED WARRANTY

The limited warranty set forth herein is given by Troy-Bilt LLC to the Initial Purchaser (as defined herein) with respect to new Troy-Bilt Battery Powered Lithium Ion Riders ("Rider") purchased in the United States or Canada.

Scope of the Limited Warranty

Troy-Bilt LLC offers the following limited warranty to the Initial Purchaser for residential or otherwise non-commercial use of the Rider: except for the Exclusions (defined herein), during the Warranty Period (defined herein), the Rider will be free from manufacturing defects (including workmanship and materials). The "Initial Purchaser" is the first person to purchase the Rider from an authorized Troy-Bilt dealer, distributor and/or retailer of such Rider products. This warranty is non-transferable. Except as otherwise set forth herein, the limited warranty period for this new Rider purchased by the Initial Purchaser is three (3) years from the date of purchase as shown on the original sales receipt for the Rider ("Warranty Period").

Defects in Workmanship or Materials

Except for the Exclusions, the Rider is warranted to be free from manufacturing defects in either workmanship or materials for the Warranty Period. During the Warranty Period, Troy-Bilt LLC will, at its option, either repair or replace any original part that is covered by this limited warranty and is determined to be defective in workmanship or material.

To qualify for this limited warranty the Rider:

1. Must have been purchased from an authorized Troy-Bilt retailer.
2. Must have been purchased within the United States or Canada by an Initial Purchaser.
3. Must have been used for residential or otherwise non-commercial purposes.
4. Must have been used in a manner consistent with the normal and proper intended use of the Rider; it is not intended for rental or commercial use.

Who can perform repairs under this warranty?

In order to qualify for the limited warranty as set forth herein, the repairs made under this warranty must be performed by an authorized Troy-Bilt service provider.

How to get service under this limited warranty:

To locate a Troy-Bilt warranty service provider, contact your authorized Troy-Bilt dealer, distributor and/or retailer or contact Troy-Bilt LLC at P.O. Box 361131, Cleveland, Ohio 44136-0019 or call 1-800-828-5500 or log on to our Website at www.troybilt.com. This limited product warranty is provided by Troy-Bilt LLC and is the only product warranty provided by Troy-Bilt LLC for this Rider. In Canada, contact MTD Products Limited, Kitchener, ON N2G 4J1, or call 1-800-668-1238 or log on to our Web site at www.mtdcanada.com. A COPY OF YOUR SALES RECEIPT IS REQUIRED FOR WARRANTY SERVICE.

What this limited warranty does not cover.

This limited warranty does not cover the following (the "Exclusions"):

1. A Rider purchased outside of the United States or Canada.
2. Damage due to lack of maintenance and/or improper maintenance as described in the operator's manual.
3. Normal wear and tear resulting from use of the Rider.
4. Normal Wear Parts (as defined herein) are warranted to be free from defects in material and workmanship for a period of thirty (30) days from the date of original purchase by the Initial Purchaser. Normal Wear Parts include, but are not limited to items such as: blades, blade adapters, grass bags, deck wheels, seats, tires, and other consumable items.

5. Use of the product that is not consistent with the intended use thereof as described in the operating instructions, including, but not limited to, abuse, misuse and/or neglect of the Rider or any use inconsistent with and/or non-compliant with instructions contained in the Operator's Manual.
6. Any Rider that has been altered or modified in a manner not consistent with the original design of the Rider or in a manner not approved by Troy-Bilt LLC.
7. Paint repairs or replacements for defective paint (including materials and application) are covered for a period of three (3) months.
8. Wheel rims (when so equipped), are covered for a period of three (3) months for manufacturing defects.
9. Attachments (as defined herein) have a one (1) year limited warranty against defects in material and workmanship for a period of one (1) year from the date of original purchase of the Attachment by the Initial Purchaser. Attachments include, but are not limited to items such as: grass collectors and mulch kits.

This warranty does not cover and Troy-Bilt LLC disclaims any responsibility for:

1. Loss of time or loss of use of the Rider.
2. Transportation costs and other expenses incurred in connection with the transport of the Rider to and from the authorized Troy-Bilt service provider.
3. Any loss or damage to other equipment or personal items.
4. Damage resulting from the installation or use of any accessory or part not approved by Troy-Bilt for use with the Rider.

Limitations:

1. THERE ARE NO IMPLIED WARRANTIES, INCLUDING, BUT NOT LIMITED TO, ANY IMPLIED WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE. NO WARRANTY APPLIES AFTER THE APPLICABLE WARRANTY PERIOD AS SET FORTH ABOVE AS TO THE PARTS AS IDENTIFIED. NO OTHER EXPRESS WARRANTY OR GUARANTEE, WHETHER WRITTEN OR ORAL, EXCEPT AS MENTIONED ABOVE, GIVEN BY ANY PERSON OR ENTITY, INCLUDING A DEALER OR RETAILER, WITH RESPECT TO ANY PRODUCT SHALL BIND TROY-BILT LLC. DURING THE WARRANTY PERIOD, THE EXCLUSIVE REMEDY IS REPAIR OR REPLACEMENT OF THE DEFECTIVE PART, AS SET FORTH ABOVE. (SOME STATES DO NOT ALLOW LIMITATIONS ON HOW LONG AN IMPLIED WARRANTY LASTS, SO THE ABOVE LIMITATION MAY NOT APPLY TO YOU.)
2. THE PROVISIONS AS SET FORTH HEREIN PROVIDE THE SOLE AND EXCLUSIVE REMEDY ARISING FROM THE SALE. TROY-BILT SHALL NOT BE LIABLE FOR INCIDENTAL OR CONSEQUENTIAL LOSS OR DAMAGES INCLUDING, WITHOUT LIMITATION, FOR TRANSPORTATION OR FOR RELATED EXPENSES, OR FOR RENTAL EXPENSES TO TEMPORARILY REPLACE A WARRANTED PRODUCT. (SOME STATES DO NOT ALLOW THE EXCLUSION OR LIMITATION OF INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THE ABOVE EXCLUSION OR LIMITATION MAY NOT APPLY TO YOU.)
3. In no event shall recovery of any kind be greater than the amount of the purchase price of the product sold. Alteration of the safety features of the product shall void this limited warranty. You assume the risk and liability for loss, damage, or injury to you and your property and/or to others and their property arising out of the use or misuse or inability to use the product.
